



What's happening

- Ongoing U.S. decoupling from China in certain strategic industries (including AI, semiconductors, telecommunications, advanced computing) that affects the automotive sector
- Expansion of U.S. export control and sanctions restrictions on exports of items, technology and services to China
- Restrictions on imports into U.S./UK/Europe from China
- Restrictions on foreign investment into U.S./UK/Europe from

Why

- Bipartisan consensus in U.S. that China is a threat to U.S. National Security and to exert pressure on European allies
- China is making gains and/or overtaking U.S./Europe in certain technologies (e.g., telecom, AI, quantum computing)
- Ongoing conflict regarding Taiwan
- ESG issues including forced labor and human rights concerns

Why it matters

- Supply chain issues for companies with operations in China, especially automotive
- Expect greater restrictions on M&A, JVs, and investment involving Chinese partners




